The roll list of the students for CCE and main examination is generated through this module. Entry of marks of practical and main examination roll number wise, generation of admit cards and second signature form for entry into examination hall is also done through this. The result prompt has also been upgraded. The processing of result, generation of tabulated register, result display, number of students for ATKT, followed by updation of marks etc is done with perfection.

Each semester examination consists of two CCE. One of these is conducted through OMR sheets, thus preparing the students for appearing in competitive examination.
